KNOW ALL MEN BY THESE PRESENTS:

This Contract executed and entered into by and between:

The NATIONAL LIBRARY OF THE PHILIPPINES (NLP) a government agency organized and existing under the laws of the Republic of the Philippines, with principal office address at The National Library Building, T.M. Kalaw Street, Manila and represented herein by its Director, ANTONIO M. SANTOS, herein referred to as the "FIRST PARTY".

-and-

The BUSINESS PARTNER ENTERPRISES PHILIPPINES, INC., a corporation duly organized and existing under and by virtue of the laws of the Philippines and duly registered with the Securities and Exchange Commission, with office address at Lola Taya Annex Building, #1165 Quezon Avenue, Quezon City, represented herein by its General Manager, MERLY A. FLORES, herein referred to as the "SECOND PARTY".

-WITNESSETH-

WHEREAS, the "FIRST PARTY" is in need of the supply, delivery and installation of a hybrid IP-PBX Networking for the upgrading of its communication equipment and facilities.

WHEREAS, the "SECOND PARTY" is willing to provide the necessary services and deliverables needed by the "FIRST PARTY".

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

A. DUTIES OF THE PARTIES

1. THE FIRST PARTY

- i. Shall for and in consideration of the supply, delivery and installation within thirty (30) days after completion, pay the amount corresponding to the deliverables stipulated on the approved TERMS OF REFERENCE (TOR) Annex "A", which shall form as an integral part of this CONTRACT, amounting to ONE MILLION SIXTY EIGHT THOUSAND NINE HUNDRED EIGHTY PESOS (£ 1,068,980.00).
- ii. May withhold payment of fee in the event that the Second Party fails to submit the required deliverables at the given period of time as stated in the attached TOR.



2. THE SECOND PARTY

- i. Assessment and evaluation of the existing communication lines of the entire building.
- Supply, deliver and install the deliverables stipulated in the TOR within thirty (30) days after the receipt of "Notice to Proceed".
- iii. Staff training for those directly involve in the new communication system.
- iv. Maintenance check-up.

B. DISPUTE RESOLUTION

- 1. All disputes, controversies or claims arising out of or relating to this Contract, or about its breach, termination or invalidity shall be settled through negotiation and/or mediation within sixty (60) days from the receipt of a notice by the other party from the party injured.
- All and any legal action arising from this Agreement shall be filed in the City of Manila; provided that the parties agree to submit to arbitration prior to the filing of any civil case arising out of this contract, pursuant to law.

C. EFFECTIVITY AND TERMINATION

- This contract shall take effect upon signing by the parties and receipt of the Second Party of the Notice to Proceed and expires after thirty (30) days.
- 2. This Agreement or any part or parts thereof, may be amended at any time, upon proper notice and consultation. Such amendment must be made in writing and must be concurred by both parties, provided that such amendment/s does/do not alter the original intent of the Contract.
