A RESOLUTION

**DECLARING A SECOND FAILURE OF BIDDING FOR THE
SUPPLY AND DELIVERY OF SERIAL PUBLICATION FOR
NATIONAL LIBRARY OF THE PHILIPPINES, TONDO AND BOHOL CONGRESSIONAL
LIBRARIES
AND RECOMMENDING THE PROCUREMENT THEREOF
THROUGH NEGOTIATED PROCUREMENT**

WHEREAS, the National Library of the Philippines Bids and Awards Committee (NLP-BAC) passed NLP-BAC Resolution No. 13-17 on December 26, 2013 recommending to the Head of the Procuring Entity (HOPE) a failure of bidding for the Supply and Delivery of Serial Publication for National Library of the Philippines, Tondo and Bohol Congressional Libraries conducted on December 26, 2013, and the same was approved by the HOPE (Annex A);

WHEREAS, NLP-BAC re-advertised and re-published the Invitation to Bid for the Supply and Delivery of Serial Publication for National Library of the Philippines, Tondo and Bohol Congressional Libraries in PhilGEPS, NLP website and in conspicuous places at the premises of the National Library of the Philippines (Annex B);

WHEREAS, on January 2, 2014, One (1) prospective bidder purchased the bidding documents. (Attached as Annex "C").

a. JPM NEWSPAPER DEALER

WHEREAS, on January 3, 2014, as of the scheduled deadline for submission of bids at 1:30PM, no interested bidder attended nor submitted the necessary bid documents;

WHEREAS, immediately after the deadline of submission of bids,, the NLP-BAC convened for the scheduled Opening of Bids (Annex D);

WHEREAS, in the absence of any received bid, NLP-BAC resolved to declare a second failure of bidding for the above mentioned procurement and to recommend to the HOPE the procurement of Serial Publications through negotiated procurement as an alternative method of procurement under Section 53.1 of R.A. 9184;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, to declare a **SECOND FAILURE** of the bidding conducted on January 3, 2014 for the Supply and Delivery of Serial Publication for National Library of the Philippines, Tondo and Bohol Congressional Libraries;

RESOLVED FURTHER, to recommend to the HOPE that the NLP resort to Negotiated Procurement as an alternative method of procurement under Section 53.1 of Republic Act No. 9184 and its Revised Implementing Rules and Regulations for the Supply and Delivery of Serial Publication for National Library of the Philippines, Tondo and Bohol Congressional Libraries;
