In view of the two (2) failed bidding, the **National Library of the Philippines (NLP)** Bids and Awards Committee (BAC) invites interested bidders to participate in the Negotiated Procurement for **Supply, Delivery and Installation of Wireless Terminal for NLP (Negotiated Procurement)** with an Approved Budget for the Contract (ABC) of **Seventy Thousand Pesos (Php70,000.00)** in accordance with Section 53.1. Bidding will be through **LOT Bidding**. Two Failed Biddings as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA 9184), otherwise known as the “Government Procurement Reform Acts”. Bids received in excess of the ABC shall be automatically rejected at bid opening.

organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Contract/delivery schedule is within Ten (10) days upon received of Notice to Proceed.

Liquidated damages equivalent to one tenth of one percent (0.001%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. National Library of the Philippines shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
